

**MEMORANDUM OF UNDERSTANDING BETWEEN
VIDYASAGAR KALA MAHAVIDYALAYA
AND
KANISHKA GRUHA UDYOG**

This memorandum of understanding (hereinafter referred to as 'MOU') is made and entered into by and between **VIDYASAGAR KALA MAHAVIDYALAYA**, whose address is **Khairi (Bijewada), Tah- Ramtek, Dist- Nagpur, Pin- 441106** and the **KANISHKA GRUHA UDYOG**, Whose Address is **Rahate Colony, Shitalwadi, Tah- Ramtek, Dist- Nagpur, Pin- 441106**.

The purpose of this 'MOU' is to establish the terms and conditions under which the two parties to this memorandum will function. The aim is to initiate and enhance the collaborative relationship between the higher education institution (HEI) and a Cottage Industry (Gruha Udyog) producing incense sticks. Since the majority of the students studying in Vidyasagar Kala Mahavidyalaya belong to the rural and tribal areas and in search of need based employability training and the firm is a cottage industry (Gruha Udyog) engaged in producing incense sticks and other such products and since both function in the adjacent geographical areas, i.e., Khairi (Bijewada) and Shitalwadi, this collaboration will be useful for both the parties.

This 'MOU' is effective upon the day and date signed and executed by the duly authorized representatives of both the parties to this 'MOU' or the governing bodies of the

parties and shall remain in full force for one year, and maybe renewed/terminated subject to renegotiation by both parties after written notice which shall be delivered by hand or by certified mail to the address listed above before three months of the date of expiry.

Responsibilities & Agreement:

The parties to this 'MOU' agree to the exchange of practical and technical experience of the incense sticks production and the theoretical concepts and knowledge of the students of the college. The two participating organizations of this MOU will conduct the activities concerning training students in incense sticks production. According to the agreement, the college would send a group of students to the firm for training and skill development. These students would learn and work in the firm on a part-time basis. After completion of training the students will be able to start their own incense sticks production unit or work in such type of production units. Both the parties shall effort to materialize the concept of 'earn and learn' practically in the conscience of the stakeholders.




